- **1.** Meeting called to order at 6:32 pm by Michael Decarreau followed by the Pledge of Allegiance and Mindfulness with Tori Cleiland.

- 3. Focus on Learning: Building Learning Communities Sara Raabe (JFK Principal) presented the Building Learning Communities. A morning meeting has been added. The morning meeting is a great way for the class to start their day. Greeting each other, sharing and activities begin the morning meeting. Professional Development was provided to the staff through a one-day workshop and the Instructional Assistants were invited if they wanted to come. A team attended Masons Care. " Also, the bullet point says July 17th, but should read July 2017.

6. Governance Processes (Policy Section IV):

- a) Policy Title: 4.2 Board Job Literacy
 - Present and Discussion Sean McMannon (Superintendent), introduced Jeanne Jensen (past CVU Board Chair, Past CSSU Board Chair) and Bob Mason (Chief Operations Officer, CSSU) to share their experience regarding Fund Structure, Fund Balance, Financial Management Review, Capital Planning Process and Audits. What is the Board members responsibility when signing warrants and in regards to the Fund Balance Reserve? Obligated by stature to have the voters vote where to allocate the Fund Balance annually, typically assigning the revenue to the following year, allocating the funds to an existing Capital/Reserve account for a specific purpose or finally assigning to "Revenue for future years". Capital Fund monies roll over to the following year. Financial Management Review happens monthly with administration. The Board members responsibility is to feel confident that funds are in good hands. The Clerk's role is to review the Warrant. If there is a question on the Warrant, ask the Business Manager for the Purchase Order and make sure all the checks and balances that relate to the PO have been met. Why does a board member review the Financial Management Review? It is to understand what is going on in the school and make better decisions. Capital Planning Process regarding capital needs includes a monthly/quarterly review and should look at facility projects completed, those scheduled and how much is in reserve with flexibility. The Audit and the role of the Board should include an audit training. Board members need to be a visible part of the Audit process and need to understand the language of the Auditor and make sure the reports that are being given to the community are accurate? An Auditor is an excellent resource with making sure the processes are in good shape, reasonable and appropriate.

Sean shared his interpretation of the Culture and Community Graduate Expectation Rubric. Board members and Student Representatives shared their thoughts regarding WSD Graduate Expectations (GXs), Diversity and Interaction and the interpretation of the rubric.
