- **1.** Meeting called to order at 6:34 pm by Michael Decarreau President followed by the Pledge Allegiance. Sean McMannon led mindfulness.

6. <u>ENDS Monitoring (Policy Section I)</u>:

a) Discussion ENDS Metrics Alignment

The discussion was brief due to two board members being absent. It will be revisited in June. This began four years ago with the boards ENDS statement. How arel the board and community going to know the progress towards the ENDS? Data has been collected over time. The four, five and six year graduation rate is key. The behavior data seems tied to reading. Michael Decarreau is impressed that college and career ready begins in kindergarten. The newest data has been collected from 2011 – 2015. Reading is local numbers. This has been tracked for a couple years. Longitude data is developed for every student for the last two years. Education Development Center (Nellie Mae) has administered survey questions for the last three years. Data is collected regarding the number of breakfasts, lunches and dinners served. Engaging in local and global community - this is hard to collect data on. Jen Corrigan suggested the Penguin Plunge and other events that students participate in could be used. Michael Decarreaubelieves that modeling plants the seed and might not have to be external.

 - Alexander Do Student Representative shared that there are only five more weeks until summer vacation! Today, Rainbow Chen is at the Allstate Music Festival representing our school. Winooski has one of the bands in the parade tonight. There are two other students in the festival besides Rainbow. One student (Key Nyguen) is representing Winooski in the Chorus and the other two (Ines Horozovic and Rainbow Chen) in Orchestra. The day concluded with an announcement to get more applicants for the new up and coming student representative to the board.
