Hilary Dubie has offered at cost photos of seniors by themselves and with family. Use photos on banners throughout the community. Adopting a senior considered for those seniors. Graduation procession-single float (Mike and Sean giving diplomas to seniors) with assistance from fire and police department. Will likely take place on graduation day. 36 students will graduate.

Size of the budget-state has been directed to make payments for students going out of the district.

\*Capital project-timing of work has been changed due to restrictions from the state.

Advantages-6% under budget from 7.5 million package. Moving ahead with the project is a good thing. Budgeting for next year-balance is troubling as funding is unknown.
