*Adam Jacobs-Husband of WMS Art Teacher Emily Jacobs. The capital project is including millions of dollars of upgrades to the HVAC system. When the outdoor temp goes down to 50 degrees, the classrooms will only be able to meet about $\frac{1}{3}$ of the minimum ventilation standards and $\frac{1}{4}$ of the ventilation standards of COVID-19. Some schools like Windham County with the same ventilation system are going remote due to the condition of the HVAC system.

*Melissa Mintzer-Middle school special education teacher - We are working hard getting things in place for the year. One thing I have concerns about is the fully remote option; is it meeting the free and public education standards? The other thing is how the families are asking if there are cases of COVID, when will we know if/when we close. I don't have answers for them.
