 - i. Discussion: 1st Reading Policy # 5111 Prevention of Harassment, Hazing and Bullying of Students

i. Discussion/Accept: Superintendent Monitoring Report

*Sean started with a discussion of the changes made to the monitoring report. According to our liaisons, the most important communication for our families is the verbal, versus the written. The board discussed some different ways to have more resources for important information. Tori talked about how to provide student voice on the school board. Kamal asked a question about spending a day at school with the students. Alex brought up whether the board members need to do FERPA training. Steven asked about using the word "undignified" within a policy. Jolivette (parent) asked a question "what has happened in the community for this language to exist?" Sean talked about the situations that have happened within the community and school.

b. Policy Title: 2.4 Financial Planning and Budgeting

i. Discussion/Approval: Capital Project Funding

*A memo was sent out regarding a contingency plan for the amount of funds that will need to be borrowed. Tom Barden explained in November that the budget will most likely be over budget by 2.8%. At the end of the '21 fiscal year, there will be about \$2.8 million in the fund balance. The memo outlines the different scenarios of how to use fund balance to help keep the USDA loan. The recommended scenario is to approve additional expenditures and borrow only the amount the voters voted on and the use of the fund balance. *Motion to approve

ii. Discussion: FY23 Budget Work Session

*Sean started the presentation with estimates from the state; specific estimates such as tech & transportation are expected to go up. Equalized pupil and CLA numbers are due in December. There is a 90 million surplus in the education fund. Nicole talked about the tax rate calculations. Education spending is divided by the property yield and gives you a town tax rate for homestead tax rate. Nicole shared some slides overviewing the budget trends over the past 8 years. There is also a slide discussing how the change in CLA and equalized pupil affects the tax rate. One slide had an overview of the past 14 years of budget voting. WSD had relied on ESSER funds for certain positions such as interventionists, special educators, and ML staff. There are a number of positions not in the current budget that would need to be added in order to maintain them. The proposed budget is based on a 6.25% increase. The overall suggestions include: full year budget based on adding positions not currently in the budget. The overall suggestions include: full year busing, moving positions from ESSER funds to permanent positions, and expanding preschool/pre-k programs.
